1. Bring completed forms with delivery of work, and exact money or cheque.
2. All works submitted will be exhibited.
3. New media/ video/ film entries should be submitted in DVD format. Submit all works as a Quicktime (.mov) PAL 720x576 PAL 16:9 wide screen. Works can be submitted as compressed, uncompressed, mpeg4 or H.264. Sound must be uncompressed stereo 48KHz. For other formats please contact the gallery before submitting your application.
4. Works that require a special setup or installation, including video works, must be accompanied by installation instructions.
5. It is the artist's responsibility to arrange their own insurance against damage, loss by any means or theft. 69 Smith Street Inc does not insure works in transit, storage, handling or exhibition.
6. It is the artist's responsibility to organise all transport matter including costs of the delivery and collection of work. 69 Smith Street Gallery will not cover any transport costs incurred in delivery or collection of work.
7. All works must be ready to hang or to be mounted – for example, hanging wires must be attached to the back of the work. Sculptures must be assembled. Wet works will not be accepted.
8. Works on paper will be pinned if they are unframed unless special hanging instructions are provided.
